INDICATIONS FOR USE

Demineralized bone matrix has been known to retain many components as a biomaterial for use in bone defects. By providing calcium-based solids and inorganic phosphates, DBM induces new bone formation and accelerates healing¹. BEAST 100™ is a DBM product intended for use as a bone void filler for the treatment of traumatic or surgically created skeletal defects.

BEAST 100™ may be used in the following procedural categories:

- Foot & Ankle
- Spine
- Neuro
- Orthopedics
- Trauma
- Reconstruction
- Dental
- Open bone voids or gaps which are not critical to the stability of the bone structure

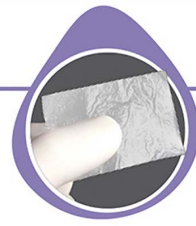

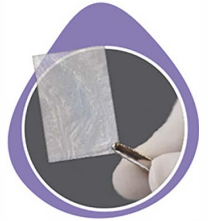
